**CONSTITUTIONAL RULES & REGULATIONS**

1. This Membership will be available to groups of 5 and not exceeding 30 persons from recognized Organisations (limited liability companies, Partnerships, Sole Proprietorships and other Firms) for all activities which in the opinion of the Executive Committee are worthy of Membership. Such Membership shall be for a period of only one Calendar Year from date of acceptance and may seek renewal at the expiry of one Calendar Year subject to the sole discretion of the Executive Committee. Members nominated by each Organisation may be substituted/replaced within the period of Membership, subject to acceptance of each substitute replacement by the Executive Committee.
2. A Nominee/Nominees of such recognized Organisation will cease to be a nominee no sooner he/she relinquishes his/her position of the respective Organisation. Each Organisation shall inform the Hony. General Secretary of the Club of such termination of that nominee within seven (07) days of taking such action.
3. Nominee/Nominees of each organization will have access to all facilities provided by the Club on payment of the prescribed activity fee applicable to ordinary Members. A nominee may introduce guests to the Club and they shall be subject to all rules/regulations of the Club, governing the conduct and decorum applicable to guests introduced by ordinary Members.
4. Members nominated by such organisations shall not have voting rights and are not eligible to be elected as Office Bearers/ Committee Members.
5. Club Financial regulations do not permit Credit facilities. All Bar and Restaurant Bills should be settled on a daily basis either by cash or credit card.
6. For all intent and purposes of this Membership the Organisation shall be held responsible for any financial accountability incurred to the Club by any of their nominees.
7. The Executive Committee reserves the right to terminate the membership of any nominee if such member conducts him/her self in anyway prejudicial or detrimental to the repute , welfare or interest of the Club.
